Official Rules

The Sweepstakes shall commence on October 21, 2024, and the deadline for the Florida Panthers Marketing Department to receive all mailed-in and digital entries for the Sweepstakes is November 8, 2024, at 11:59 PM Eastern Standard Time ("Sweepstakes Time Period"). No entries will be accepted after such time.

- 3. PRIZE AND ODDS: Following the conclusion of the Sweepstakes Time Period, Sponsor shall select one (1) Eligible Person ("Winner") from a random drawing of all eligible entries received during the Sweepstakes Time Period to receive two (2) tickets to The Driver Era show to take place at the entertainment facility currently known as War Memorial Auditorium on March 7, 2025, with such tickets to be for seats to be determined by Sponsor in its sole discretion, and one (1) one-hundred dollar (\$100) gift card to the restaurant known as The Federal ("Prize"). Each entrant is responsible for monitoring his/her Instagram account for prize notification and receipt or other communications related to this Sweepstakes.
